

Mr. Mintz is one of Custard Insurance Adjusters' premier adjusters who has managed and worked losses throughout the world. His formal education includes a B.A. from the University of California, Irvine as well as certified courses of study in energy, oil and gas from the Colorado School of Mines. He is undergoing a course of study to complete an MBA from Auburn University. Additionally, he holds a Certificate in General Insurance, an Associate in Claims, a CLM Fellow and is an Associate Certified Fraud Examiner. Mr. Mintz is also a licensed private investigator to complement his 31 State independent adjuster licenses.

Throughout his 38 year career, that commenced with 9 years at a domestic carrier, he moved into independent adjusting, becoming involved in personal and commercial lines. Since 1990 Stuart has been involved in the international marketplace and has worked and managed several world catastrophes, including the typhoons and hurricanes in Florida, Hawaii, Texas, Alabama, Louisiana, Caribbean, Guam, New Zealand and Thailand, as well as earthquakes in San Francisco, Los Angeles, Guam and New Zealand. He has also attended losses in China, Central and South America and the Caribbean.

Stuart's expertise includes the handling and managing of commercial large loss complex property and time element losses with a particular emphasis in manufacturing, habitational, real estate, restaurants, office buildings and high rise complexes, course of construction; specie that includes: jewelers and fine art block/ armored car, entertainment and contingency, as well as utilities/ power plants, oil and gas, liability and wet/ dry marine and fraud investigations that are all areas of expertise that he is involved.

In addition, Mr. Mintz has handled several high profile losses including the World Trade Center attacks, including some US \$700 million in property damage and recovery of approximately US \$300 million in bullion. Currently Mr. Mintz is handling excess of US \$50.0M claims in Texas, Florida and Santa Rosa, CA.

Stuart was a supervisor overseeing risk management at the 1984 Olympic Games and led a team of adjusters in the 1994 World Cup and 1996 Summer Olympics for the European Broadcasting Union's personnel and equipment. Mr. Mintz is a frequent presenter / panelist at both the Loss Executives Association and PLRB and is a certified continuing education provider, umpire and appraiser of first party property losses.
